
Directors' Note for Portfolio Groups

Portfolio title: Witheridge Local Governing Body Date of meeting: Thursday 14th November 2019 Attended by: Sue Wells (chair), Phil Asson, Adrian Wells, Simon Clarke, Chris Holding, Lucy Ratcliffe, Verity Goss (clerk)



The next term's topic was 'Farm to Fork' – the school had previously built links with a local farm, but would be looking to expand this.



<u>Teacher Assessments – Y1, Y3, Y4, Y5</u>

Data had been distributed in advance. CH talked through the data.

Phonics screening – CH stated that normally a higher percentage passed the phonics screening test than had the previous year – CH explained the needs of children in the cohort, who had a low level of attainment at EYFS. Progress in Y1 was very positive – narrowing the gap.

Y2 – high levels of SEN, specifically in reading which then affected progress in that area.

Were the SEN children in this class also Pupil Premium? No. One PP child achieving greater depth, the other two at expected standard.

Y3 – were some issues with progress in this age group. CH explained the support that was put in place during that year. CH explained the recruitment process to ensure the quality of teacher would be that which was needed in this class.

Y6 (previous year's cohort) – very positive results, especially given the level of SEND in that cohort.

Progress scores as calculated by the DfE – judged as average for maths and writing, well above average in reading.

Discussion on the reason for the sudden increase in progress in the school in reading. CH stated that whole class reading had been introduced in KS2, but there had not been a significant amount of other alterations. Some children were reading at home, but not all – opportunities for children to be heard reading within the school discussed. Currently had one volunteer who listened to children read, but would always welcome anyone who wanted to come in and listen. CH stated there were some occasions of older and younger children reading together, but that this was not a regular item as it was important for the more able children to be able to continue reading texts which were challenging to them.

School Improvement Plan (MAT issues) inc EYFS

All had received and read. CH further explained the main points.

CH explained how subjects leads were used within the school setting, and how these worked together across TEAM. All children expected to make some progress from their starting point – CH clarified that this was different to 'expected progress', and that not all children would make as much progress as their peers, depending on individual needs.

Aspirations – schools were organising a day where former pupils would come back to talk about what they were doing now.

Devon Enhanced Learning Programme – staff were being trained in this programme. Each child is screened and identified for any speech and language needs (including low level), then recommendations are given for support to be put in place.

EYFS – developing reading for pleasure. CH reported that children were enjoying stories being read to them.

Improving progress/end of Key Stage outcomes in writing – CH explained the use of a specific spelling program.

What resources were being put into intervention work? Currently have the capacity to have TAs able to work with children on interventions. Some children had EHCPs which then had the requirement of a specific staff member for those children. CH explained intervention work was for individuals and small groups – short sessions of no more than 20 minutes. Staff were careful of when these interventions took place so that children were not always missing the same part of the day/felt resentful of these sessions.

<u>School specific SIP and Group specific learning support</u> Covered above.

<u>Targets</u>

Set across MAT as 80% making expected progress for all year groups across all schools. KS2 Witheridge target to maintain the 75% currently achieved. LGB over the next few months to monitor how successful strategies for writing were proving.

<u>Pre-School Update: inc hours, staffing, numbers, holiday club</u> Currently 16 in pre-school, ten due to start reception in September. Numbers will increase through the year as children turn three and gain funding. Pre-school still currently viable.

Staffing – one staff member currently on maternity leave, no change apart from that.

Holiday club currently continuing – continually assessed to ensure remains viable.

Safeguarding Report No matters to report to this meeting. LGB members signed to say they had read Keeping Children Safe in Education and the Codes of Conduct.

Health and Safety: inc summer improvements

Wall in playground shelter has been replaced.

Roof has been completed – no longer leaks. Some issues with security light coming on when it rains – currently working on correcting the sensitivity. Timetable for painting been drawn up. CIF bid being put in for the windows and fascias to be done – result of this would depend on other schools on the priority order.

Feedback from governor training

SW and AW had attended DAG conference and gave feedback. Had been informed that governors were being asked on Ofsted inspections what they knew about what DCC were doing to improve SEN provision. SW explained what information they had received about SEN in Devon. Resources to educate governors about this issue were being prepared.

Elective Home Education – it was recommended that the Designated Safeguarding Lead talk to children without the parent present before they leave for safeguarding awareness.

Taking care of the Safeguarding Lead was discussed, and being mindful of support they might need based on what information they may become aware of. CH explained what staff would do if they felt in need of support.

The conference had also included an overview of what a New Ofsted Framework inspection looked like, starting with 90 minute phone call with the headteacher, then visiting the school where they will 'dive deeper' into certain areas. Primary inspections would always include reading in their 'dive deeper'.

SW had completed observations on two collective worships, governors discussed what could be done to support visitors who came in to lead collective worship.

Strategic

Review pupil numbers, projected numbers, staffing, attendance

Pupil numbers – 74 on roll, 16 pre-school. 12 new parents had attended the parent information evening for children starting reception next year, or were known to have children right age. 10 children would come from pre-school, two elsewhere. CH reported it had been a positive meeting. Numbers on roll would increase by three in September. New housing development currently being built in the village.

Staffing – has been some turnover of TAs for SEN support. CH updated governors on EHCP progress, which increased the TA requirements needed.

Attendance – overall 96.75%. Pupil Premium 94.1%, which included four children who had taken a week's holiday. SEN attendance 97.29%. Five children classed as persistent absentees – four of these were those that had been away on holiday, the other had had short term medical issues.

One child currently at pre-school will have an EHCP in place when they start school requiring one-to-one support – will need to appoint to this role over the summer.
